	1 The meeting was chaired by BDAQ President, Tamica Lewis who opened the meeting at 2.04pm and welcomed all attendees.			
	2 The chair, confirm that a quorum was present, and the meeting is duly constituted – 48 present (quorum required – 27), plus 2 guests/observers and 36 proxies.			
	Due to the change in format to be online via Zoom, any financial member (full, life, fellow) attending online may vote on all motions presented. Each member will get one vote unless they have been nominated to vote on behalf of another member via a proxy form. Head Office will calculate results of each motion, including calculating proxy votes.			
	4 Zoom's polling feature will be used to vote for each motion. As each motion i presented by the meeting chairperson, attendees will see it appear in their			





- Zoom window. Three options will be given affirmative, negative, or abstain. Attendees will be given one minute to vote before polling is closed.
- 5 Head Office will calculate the results after each motion and the full breakdown of votes, including proxy votes, will be shown to all attendees.
- 6 A practice motion will now be presented to ensure all attendees are familiar with this process.
- 7 Those who wish to second a motion must unmute and speak.

7.1 Change of Trading name and Rebranding.

Tamica explained that the full motion does not fit in Zoom polls – full motion to be read out, types in the chat bar, and members to vote yes or no on understanding, then affirmative/negative/abstain on this motion.

Motion

That the Building Designers' Association of Queensland (BDAQ) accepts in full the proposed change of name and logo as presented.

The association will adopt Building Design Queensland (BDQ) as a trading name, retaining Building Designers' Association of Queensland as our official entity name. The proposed logo for adoption will be representative of BDQ and in the format as attached.

Moved by: Owen Kleidon

Discussion

Tamica requested that 30 minutes has been allowed for the discussion, and that when a member is speaking, we ask that others do not interrupt them.

Owen shared his screen to show the logo, supporting collateral and video.

Owen addressed the request that has been made (unofficially) for two motions – one for the trading name, the other for the logo. I can't see practically how one





could be done without the other and as a result we have brought it as a single motion for consideration.

Ron: It's my intention to propose an amendment to the motion.

I move

That The Building Designers' Association of Queensland (BDAQ) approve the following motion proposed by the Management Committee amended as follows

 a) The name, Building Designers' Association of Queensland Incorporated appear on all material including web pages and advertising in accordance with Clause 32 of the (Qld) Associations Incorporation Act 1981 Current as of 1 April 2021,

Associations Incorporation Act 1981 Clause 32
Registered name of incorporated association to appear on documents
An incorporated association must ensure a document it endorses, or issues
(including advertising material) has the association's registered name in legible
English characters.

- b) [no change] The Building Designers' Association of Queensland (BDAQ) retain the name Building Designers' Association of Queensland;
- c) [minor change]The trading name Building Design Queensland (BDQ) and the logo as presented in the motion Special Business Item – 2021 BDAQ General Meeting GM01, be approved, with the addition of the wording of the legal entity, 'Building Designer's Association of Queensland Inc", in accordance with the requirements of the Act;
- The approved trading name be added to the Association By-Laws, and not to the Rules of Association;
- e) The Building Designers' Association of Queensland (BDAQ) allow members and branches to choose to use the entity name and logo or the trading name and logo, as they or their members see fit, and
- f) The Building Designers' Association of Queensland (BDAQ) retain the current logo as our official logo as it is referenced in the Rules and linked to our legal name Clause 4 Classes Of Membership.

Rob: just from an advisory point of view, there are 7 different motions there, it should only be one. Your part a is exactly what has to happen anyway – if Building Design Queensland is adopted, every piece of documentation must have Building Designers' Association of Queensland Inc. trading as Building Design Queensland on it. There's plenty of other organisations who do this now where that example can be demonstrated.

Ron Smythe: this is based on the information provided – it didn't have anything about the legal name on the logo. If that is the case that will happen as a matter of





course. To me it is one motion in relation to what was proposed – it just sets it out as what happens as a result of the motion being approved.

Olivia: part c, the apostrophe goes after our Designers in our name, so if you want this approved that apostrophe needs to be in the right place.

Tamica: Ron, given Rob's information are you still wanting to bring this motion or are you saying you're happy it will be dealt with as you've asked.

Ron: I'd still like to move the amendment, because there is confusion because we will still retain the legal name of Building Designers' Association of Queensland Inc so we should still be able to use that name. But that's nt covered in the proposed motion.

Tamica: is there anyone else who would like to speak to Ron's proposed motion? **Peter**: Ron does have a point here, but I was wondering. If we are going to have trading as, doesn't that make the whole idea moot?

Rob: the response to that is that you can have in much larger letters Building Design Queensland at the top of your letterhead, as long as that piece of paper has somewhere on it Building Designers' Association of Queensland Inc trading as Building Design Queensland.

Olivia: Design Matters National is a good example of this – it's at the bottom of their website, and all important documents, but doesn't need to go on promotional or marketing materials.

Tamica: Just checking Ron, are you sure you still want to bring this motion now? **Ron:** Yes, because Design Matters is Victorian and not covered under the Incorporated Associations Act for QLD which says it must appear on all documents including marketing material. So, we'll have both names on everything – wherever the logo appears.

Tamica: if you do still wish to bring this motion, I will still have to ask for a second. **Ron**: under our rules, seconders are only required for nomination of office bearers. Our rules do not require a seconder for procedural motions – they can be raised by members, debated, and then voted upon.

Owen: not to be contrary but the motion says that what you really want to do is create a division within the Association – those who wish to wish to be known as Building Designers' Association of Queensland and those who wish to be known as Building Design Queensland. Those who wish to trade under a new logo, those who wish to take advantage of the marketing and support provided and those who don't.

Ron: there really isn't a division – we still are the Building Designers' Association of Queensland Inc., those who wish to use the Building Design Queensland can use





that. Unless we change the rules, we are officially the Building Designers' Association of Queensland Inc. so there is no division.

Tony Hague: there will be as far as the public in concerned - from their perception of us.

Ron: Legally we need to put Building Designers' Association of Queensland Inc. on everything.

Tony: in small font, sure. But not have some members keep BDAQ and some members keep BDQ. I don't see that helping us at all.

Ron: I don't believe that will affect if individual branches want to vote and choose what they want, or individuals choose what they want. I don't have BDAQ on my letterheads or title blocks – some people do and some people don't. I think we're probably overstating the anxiety caused by the community. When people come to see you as a Building Designer, the logo is the least of their concerns.

Tony: but if they're comparing and contrasting with other Building Designers, why are two Building Designers members of slightly different but the same thing? It just looks fractious.

Ron: the simple answer is that our legal name is Building Designers' Association of Queensland Inc. and our trading name is Building Design Queensland. So I think that's a very short conversation.

Elaine Silver: may I ask a question? I'm a newbie so if I'm in the way I'll hold back. **Tamica:** most certainly Elaine.

Elaine: As a new member and having come from Victoria where I was absolutely horrified at what happened to my old Association, I've been following the work being done this year to make it clear who we are, where we're aligned, what we're proud of and what we're good at. And I'm very proud to be a new member. I very much like the modernisation of our logo and name, and I'm very concerned with the bottom three bits of this – possibly 'd' is a point of order that's part of our constitution – but I'm very concerned that we need to either adopt Building Design Queensland as our name and logo whilst still recognising that there is a legal requirement to include something else at the bottom. It would be as if Westfarmers or Coles or Dan Murphy's or whoever they were gave a choice to each shop: you can call yourself Bunnings or you can call yourself the Westfarmers Hardware Store Inc or whatever their legal name is. So, I'd be very keen to adopt in full that all of us are going to use Building Design Queensland, or not. Because I think it is very confusing and retrograde if we can pick or choose. That's a personal opinion and thank you for letting me speak.





Tamica: Thank you Elaine, and it's probably an opinion many people would be in favour of. Shall we just move on and vote on Ron's proposed amendment?

Rob: Before you do, I believe by reading the Rules that it does require a seconder.

That is in

Tamica: so shall I ask for a seconder?

Olivia: before you do, I'd like some clarification around what you want displayed for this motion on the poll. Obviously, this is a very lengthy motion, and won't all fit in the poll field, so what I've currently got is: *Multiple; as shown on screen shared by Ron Smythe.* Is that clear enough?

Ron: I'm happy with that, Olivia.

Olivia: so, to clarify, an affirmative vote in this poll is saying you agree with everything currently displayed on the screen, negative is that you do not agree, and abstain is obviously abstaining.

Tamica: so that's been moved by Ron. I will ask for a seconder – is anyone prepared to second that motion?

No members seconded the motion.

Tamica: we will move onto the final motion for the meeting. As Owen spoke to earlier – Owen has read out the words.

Owen Batchelor: my perspective, I have no issue with trading name – I agree 100% with the name Building Design Queensland – I like it, it's easy to say, it's easy for clients to resolve with. My issue is that this motion, which I see as being two separate motions about two different parts of our constitution have been rolled into one. I don't like the logo, I don't like the colour, I don't like the BDQ, I don't like any part of it.

As a full member, member since 1995, I plan to vote against it. I'd like other members to think for themselves – if they're not sure about it, or they're not sure and going to vote for it because they couldn't be bothered voting against it, this is your Association and you get to choose the things that happen in your Association as a member, your vote does count. Thanks Tamica.

Tamica called for a seconder for the motion Owen put forward earlier. **Olivia** clarified the setup of the Zoom poll.

Tamica and Evan invited the members of the Marketing Sub-Committee to talk about the logo and the process of getting to the final version.

Craig van Heerden summarised: it's text-based because we believe that was the best way to animate what we're doing. It's dynamic – links to a new generation of designers who are coming into he BDQ. It's a new logo for a new time – will be well-received by the public.

Anthony Trevor pointed out that while the Association is doing well currently, this can be a catalyst in pushing us to the next level. Gives us an opportunity to build the member base with professionals who are within the Building Design industry.
